- Prepare some street scene elevations to demonstrate the relationship of the proposed building within the existing environment.

# Item 7 BASINGSTOKE CANAL JOINT MANAGEMENT COMMITTEE CONSULTATION ON THE REPRESENTATION OF HART PARISHES

At its last meeting the JMC (which overseas management of the Canal) resolved to review its current membership. This is as a result of a vacancy amongst the Committee's current Special Interest Group members, but also as a result of a request from Fleet Town Council wishing to become a full voting Member of the Committee.

The Committee resolved to postpone any decision until its October meeting. This was in order to allow expressions of interest from special interest groups for appointment to the vacant position; but also to allow consultation with partners, riparian parishes and existing special interest groups on whether there was a need to review voting rights.
