Item 9 SECTOR LED BODY FOR EXTERNAL AUDIT

As a result of the abolition of the Audit Commission in April 2015, the arrangements for external audit will be changing from April 2017. In future parish and town councils will be able to choose to have an auditor appointed to them by a new "Sector-led Body" (SLB) or they can decide to procure their own.

Parish/Town Councils wishing to participate in the SLB do not need to do anything as all smaller authorities are automatically opted in to the new body and will have an auditor procured for them. However, Councils are able to opt out of this arrangement and the decision would need to be advised by 31 March 2016.

Smaller Authorities' Audit Appointments Limited is the Sector Led Body and has been set up on behalf of the Department for Communities and Local Government by NALC, SLCC and the Association of Drainage Authorities.
