- Central ward being divided with Reading Road North and Reading Road South being used as the dividing line
- retaining the Harlington Centre as the Polling Station to serve Fleet West and Calthorpe wards.
- Whether it was appropriate to submit these views direct to the Boundary Commission and if so that Mr Tiffin be authorised to so write.

It was also agreed that the completion of the on-line survey be delegated to the Chairman and Clerk.
