**RESOLVED**

1st preference:	Approach 3	New Settlement
2nd preference:	Approach 1	Disperse throughout towns and villages
Least preferred:	Approach 2	Strategic Urban Extensions at main settlements

- b) That the recommended response from Fleet Town Council to Questions 5 asking which of the three mixed approaches should be adopted (if required) were ranked by Members as follows:

1st preference:	Approach 6	New Settlement and Dispersal
2nd preference:	Approach 7	Combination of New Settlement, Dispersal & Strategic Urban Extensions
3rd preference:	Approach 5	New Settlement and Strategic Urban Extensions
Least preferred:	Approach 4	Strategic Urban Extensions and Dispersal

- c) To produce a flyer clarifying the implications of the various housing options for Fleet and recommending the Council's Preferred option.
- d) To delegate authority to Cllr Alan Oliver and The Clerk to finalise the content of the flyer taking into account the comments from members.
