Item 12 GENERAL POWER OF COMPETENCE

The General Power of Competence (GPC) allows eligible local Councils "the power to do anything that individuals generally may do" as long as they do not break other laws. This is the power of "first resort".

Fleet Town Council meets the eligibility criteria ie

- Two thirds of the Council must be elected (even if the election was not contested) For Fleet Town Council this is 12 members. Out of the 18 members that Fleet Town Council should have, there are currently 3 vacancies
- The Clerk must hold one of the sector-specific qualifications including the passing of Section 7 of CiLCA 2012 (GPC) - The Clerk is CiLCA qualified including the GPC qualification.

Fleet Town Council to consider and confirm its eligibility to use the General Power of Competence.

RECOMMENDATION

Members to resolve that Fleet Town Council meets the eligibility criteria to use the General Power of Competence as at 16 May 2018

- Fleet Town Council has 15 eligible Councillors
- The Town Clerk is fully CiLCA qualified including Section 7 (GPC)

Item 13 LEASES

Members will recall that at the meeting of Council on 6 July 2016, the following resolution was passed in relation to the leases for :

- Fleet Cricket Club in Calthorpe Park
- 1st Crookham Scouts in Basing borne Park
- 22nd and 26th Odiham Scouts in Calthorpe Park

'to waive the rent set out in the Particulars to the lease so long as the Tenant shall act in the spirit of the lease and occupy the premises fully in accordance with the terms of the lease. The Tenant's performance against this waiver shall be reviewed by the Council annually. Failure to comply with the said terms shall result in reinstatement of the full rent as set out in the Particulars'

Members are asked to authorise the continuation of this waiver in the leases

RECOMMENDATION

To approve the continuation of the rent waiver in leases
